1. Establish list of visitors present who wish to address the Board/Hear from Public.

2. Consent Agenda

5. Attorney’s Report, including: report on status of annexations, including approval of Development and Annexations Agreements; amend Rate Order; and approve Interlocal Agreements with Harris County Flood Control for Drainage Facilities.

6. Approve Park and Recreation Manager’s Report including: (a) report on District Management, Park operations, and approve expenditures related thereto; (b) approve amended Rules and Regulations for Park Facilities; (c) authorize purchase of equipment, inventory and supplies; (d) project status report, and (e) approve award of contract for facilities relating to parks and recreation.


