1. Establish list of visitors present who wish to address the Board/Hear from Public.

2. Hear Peace Officer’s Report and take any action thereon.

3. Discuss Hazard Mitigation Plan/Application Grant Applications, and drainage/flood mitigation matters and take actions related thereto.

4. Engineer’s Report, including: (a) report on status of construction projects and take action related thereto, including approval of pay estimates and change orders; (b) approve preparation of plans and specifications for District projects and authorize advertisement of bids relating thereto; (c) approve award of contracts for construction projects; (d) discuss capital projects plan and take action related thereto; and (e) discuss and take action on requests for service, including annexations.

5. Discuss and take action on Drainage Policy and annual certification of Detention Facilities.

6. Operations update and take action related thereto.

7. District Manager’s Report including: (a) report on District Management, Park operations, and approve expenditures related thereto; (b) approve amended Rules and Regulations for Park Facilities; (c) authorize purchase of equipment, inventory and supplies; (d) project status report, and (e) approve award of contract for facilities relating to parks and recreation.

8. Maintenance Manager’s Report including: (a) authorize purchase of equipment, inventory and supplies; (b) project status report, (c) approve award of contract for facilities, and (d) authorization of maintenance projects.



10. Discuss and take action on trash contract.

11. Attorney’s Report, including approval of (i) Amended Rate Order; and (ii) approval of Minutes of February 12 and 20, 2025.
