**7. Personnel and Administrative Report including:** (a) consider status of personnel, authorize pay increases, and hiring/termination of personnel; (b) approve changes to Employee Manual, (c) conduct employee review, and (d) discuss and take action on 401k Plan.

**8. Hear report on flood mitigation/drainage matters and take any action thereon.**

**9. Discuss and take action on legislative matters.**

**10. Hear Committee/Liaison Reports and take any action thereon, including:** (1) Flood mitigation; (2) Parks/Recreation; (3) Water/wastewater; (4) Solid Waste; and (5) Financial.
