DUES AND FEES AS OF AUGUST 1, 2025

- Monthly club fees can be added to the resident's monthly water bill or prepaid by cash/check/card for 3 / 6 / 12 months.
- Harris County WCID110 resident membership options:
 - Full Membership on Water Bill: \$35 per month/per household
 - \$200 reinstatement fee for water bill renewal within first year from cancellation.
 - \$100 reinstatement fee for water bill renewal within 2nd year from cancellation.
 - Temporary Membership (3 / 6 / 12 month pre-paid): \$45 per month/per household
- Harris County WCID110 senior residents (65 & older) \$15 per month/per household
 - Seniors only & minor grandchildren under 21 will be permitted
- Access and Photo ID Cards
 - Two (2) adults only & minor household children under 21 per membership
 - Two (2) access cards limit per household per membership for Primary and Secondary Adults.
 - Touch access card to access pads on gates or doors to unlock.
 - Replacement access cards are \$15 each.
 - Photo ID cards required for children 6 to 21 – these do not gate or door access capabilities.
 - Must have ID's on them at all times.
 - Replacement photo id cards are \$5 each.
- Guest Fees: Guest fees are \$5 per adult & \$2 per child under 18 years old). Limited to two (2) guest per member are permitted after guest fees are paid in Forest Oaks Admin Office or at pool.
