

AMENDED AND RESTATED NOTICE OF MEETING


HARRIS COUNTY WATER CONTROL AND IMPROVEMENT DISTRICT NO. 110

Notice is hereby given that the Board of Directors of **Harris County Water Control and Improvement District No. 110** will meet in regular session, open to the public, at 19023 Joanleigh, Spring Texas, 77388, the designated meeting place of the Board of Directors inside the boundaries of the District at **9:00 a.m., on Thursday, April 16, 2026.**

- 2. Hear Financial Advisor's Report and take any action thereon, including a report on the Park Bond Application.**
- 3. Hear Revenue Management Report Services Report and take any action thereon.**
- 4. Discuss and take action on commercial detention pond maintenance and repairs.**
- 5. Discuss and take action on contract for pool and park facilities.**
- 6. Engineer's Report, including:** (a) report on status of construction projects and take action related thereto, including approval of pay estimates and change orders; (b) approve preparation of plans and specifications for District projects and authorize advertisement of bids relating thereto; (c) approve award of contracts for construction projects; (d) discuss capital projects plan and take action related thereto; and (e) discuss and take action on requests for service, including annexations.

Consulting Engineer's Report, including:** (a) report on Cypress Oaks Detention Basin and take action related thereto, including approval of pay estimates and change orders; (b) approve preparation of plans and specifications for District projects and authorize advertisement of bids relating thereto; (c) approve award of contracts for construction projects; and (d) discuss and take action on joint projects with Harris County Flood Control District.
- 8. Operations update and take action related thereto, including approval of termination of service to accounts for non-compliance with Drainage Policy, delinquencies and violations of Rate Order.**
- 9. District Manager's Report including:** (a) report on District Management and Park operations and approve expenditures related thereto; (b) approve amended Rules and Regulations for Park Facilities; (c) authorize purchase of equipment, inventory and supplies; (d) project status report, and (e) approve award of contract for District and Parks and Recreation facilities.
- 10. Maintenance Manager's Report including:** (a) authorize purchase of equipment, inventory and supplies; (b) project status report, (c) approve award of contract for District facilities, and (d) authorization of maintenance projects.

- 12. Personnel and Administrative Report including:** (a) consider status of personnel, authorize pay increases, and hiring/termination of personnel; (b) approve changes to Employee Manual, and (c) conduct employee review.
