**5. Approve Maintenance Manager’s Report including:** (a) authorize purchase of equipment, inventory and supplies; (b) project status report, (c) approve award of contract for facilities, and (d) authorization of maintenance projects.

**6. Personnel and Administrative Report including:** (a) consider status of personnel, authorize pay increases, and hiring/termination of personnel; (b) approve changes to Employee Manual, (c) conduct employee review, and (d) discuss and take action on 401k Plan.

**7. Attorney’s Report.**

**8. Hear report on flood mitigation/drainage matters and take any action thereon.**


**9. Discuss and take action on legislative matters.**
